During the planning for the Smart Schools Investment Plan, Cincinnati Central Schools completed a survey of their building in consultation with Hunt Engineers and Architects and Central New York Regional Information Center. During the course of this survey they identified primary sites for the installation of wireless access points such as classrooms and science labs. Additional locations in gymnasiums, cafeterias and the auditorium where it would be beneficial to also have access points were also identified. In the preliminary budget funds were allocated for the primary locations. The district was able to take advantage of NYSOGS contracts to reduce their prices from earlier submissions. The district wishes to take advantage of the savings and purchase the additional access points required to equip ALL of their facilities, including those that might be used for Regents and State Wide on line testing.
