Dear parents, care-givers, community members, and students,

Our team has worked diligently to provide the best guidance we can in regard to preparing our facilities for student and staff use. We completely understand that we will start this school year with a host of unknowns in regards to the spread of COVID-19, which model of operating conditions we will be using from one week to the next, whether or not we will have athletics, or if all of our friends will be attending school in-person or virtually. It is the unknown that provides a great deal of anxiety for all of our stakeholders, but most especially for students.

Let's acknowledge that school will look differently than it ever has, over which we have little control. We will wear masks. We will practice social distancing. We will utilize one-way traffic in hallways. We will limit movement as much as possible. We may have to move to full distance learning if advised from the Health Department or the Education Department. These facts make me especially anxious because I feel responsible for each person that walks through our doors in the morning, but mostly it makes me sad that our students and staff didn't sign up for these conditions at Cincinnati.

Although I have to acknowledge and plan for those 'uncontrollables', I am also choosing to redirect my thinking to those things that I can control. I can control my attitude and my willingness to engage in practices that will protect me and those with which I will be near. I am not a doctor, but I will follow the science as it is being presented by the experts. I have control over my effort to help others. I will work with staff and families that are reluctant to return to in-person learning. We have emphasized the importance of building relationships and a positive culture as a part of our core as a school; current circumstances give us the opportunity to serve others in a more meaningful way. I accept that challenge.

As of Wednesday, July 29, we will start with Condition Yellow, which states that we will start school on Tuesday, September 8, with all students. We will have procedures to wear a mask during instruction unless the teacher grants a mask break. If a student is in motion, they must wear a mask. Guidance from Dr. Gupta, the Onondaga County Health Commissioner, is that all persons in the building wear a mask all the time as this is the safest way to be engaged with in-person learning.

This guide is a draft. We have the ability to make edits and adjustments prior to the start of school and we have a management right to move between operating conditions of red, orange, yellow, and green as conditions warrant. We will continue to monitor our practices and procedures in school and make any necessary changes as we deem necessary. When students come back to school, we will see how effective our planning process holds up.

After the Governor makes a determination next week regarding school operations throughout the state, we will be posting surveys to our website regarding school, transportation, and provide an opportunity for you to give us feedback.

Understanding that you may not want to read all 61 pages of this reopening document, we have attached the Reopening Plans by grade level on our website. In addition, we have posted our Social Emotional Learning Plan for your review as well.

As we receive further information, I will message that out using our School Messenger system. You can expect some information regarding Health Screening Procedures for your children at home as well as some adjustments to the student drop off procedure in the coming weeks.

On a personal note, I have great appreciation for the opportunity to be the Superintendent of Cincinnati and I love working with children each day. Since March, that joy has not been available and I look forward to operating as normally as possible. If bringing our entire student body to school each day is dependent on wearing a mask and social distancing, then I am going to do just that. It is worth it for me to have the magic the students bring to make this building become a school. I thank you all for your patience and understanding.

We will continue to monitor local health considerations including the number of cases of COVID-19 in Cortland County as included in the daily briefings well as regional numbers of cases in Central New York State.

3. Ongoing communication with staff and families including website updates, letters home, and emails to staff to include:

- Training provided to students, families, staff to include:
 - Hand hygiene
 - Respiratory hygiene
 - Social distancing and use of face coverings
- Signage within building to include:
 - Hand hygiene
 - Respiratory hygiene
 - Social distancing, face coverings, and directional signs for hallway traffic

 - Hand hygiene
 - Respiratory hygiene

4. Each school and/or district reopening plan has a written protocol developed in collaboration with the district or school's director of school health services to instruct staff to **observe for signs of illness** in students and staff and requires symptomatic persons to be sent to the school nurse or other designated personnel.

- Training for staff to include:
 - Signs and symptoms (s/s) of illness: symptoms may appear 2-14 days after exposure to the virus
 - Fever or chills
 - Cough
 - Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
 - If staff member or students present with any s/s of illness, symptomatic person must report to school nurse immediately

Daily Health & Temperature Screenings

5. Cincinnati Central has a protocol for daily temperature screenings of all students and staff, along with a daily screening questionnaire for faculty and staff and periodic use of the questionnaire for students.

Screenings:

- Staff screening and questionnaire:
 - at home via an app downloaded to a phone or tablet prior to coming to school created by OCM BOCES
 - Screening to include temperature and questionnaire DAILY prior to staff coming to work
- Student Temperature Screening off bus:
 - Students off load buses, maintaining single file line and 6 feet apart
 - Student wear masks through screening process and in hallway to classroom
 - Screeners at both entrances in bus loop
 - UPK - 6 in South Entrance # 16
 - 7 - 12 in Senior Lounge Entrance # 15
 - Students will enter single file for temperatures to be taken
 - If temperature under 100.0 students will enter, go to class or breakfast (then to class)
 - If temperature over 100.0:
 - Student sent directly to Health Office
 - Nurse notified by radio or phone call that student is being sent to Health Office (or student is escorted to Health Office by CCS employee)
 - Nurse assumes care of student
- Student Temperature Screening Visitor Center:
 - Students either walking in from drop off location or dropped at sidewalk will continue to wear mask through screening process and traveling in hallway to classroom
 - Students of employees will enter through Visitor Center for daily screening
 - Students enter single file, maintaining 6 feet apart if possible, for temperatures to be taken
 - If temperature under 100.0 students will enter, go to class or breakfast (then to class)
 - If temperature over 100.0:
 - Student sent directly to Health Office
 - Nurse notified by radio or phone call that student is being sent to Health Office (or student is escorted to Health Office by CCS employee)
 - Nurse assumes care of student
- Student questionnaire screening:

- We will also continue to message parents on the signs and symptoms of COVID-19 and encourage them to screen their children at home daily and report to the school nurse if there are symptoms.
- The school nurse will periodically screen students using questionnaire included in this document.
- Screening to be done weekly by random selection of students per the Department of Health guidance.

6. Cincinnati Central requires that ill students and staff be assessed by the school nurse and all ill students and staff will be sent home for follow up with a healthcare provider.

- Any identified ill staff or students will be assessed by the School Nurse. Treatment will be based on assessment findings.

7. Cincinnati Central requires all students or staff with a temperature, signs of illness, and/or a positive response to the Cincinnati Central questionnaire to be sent directly to a dedicated isolation area where students are supervised, prior to being picked up or otherwise sent home.

Any staff or students with a temperature, signs of illness, and/or positive response to the questionnaire will be sent directly to room 400, a dedicated isolation area.

- Staff will be sent home immediately
- Students will be supervised by a CCS Employee until being picked up or otherwise sent home
- Bathroom will be available for any person in isolation
- Supervising person will be in appropriate PPE (see below plan for rm. 400)

Room 400 Plan (Isolation Room):

- Any student who presents with a temperature of 100.0 or greater will be escorted by designated school personnel to room 400 for isolation.
- Negative pressure isolation will begin
- Students will be supervised at all times while in isolation
 - Supervising person will be in full PPE (gown, gloves, goggles, mask)
- Students will use bathroom next to room 400 if necessary
 - Bathroom will be shut off for other use until thoroughly cleaned and disinfected
- Point of contact (Megan Potter) will notify Cortland County Health Department of temperature and isolation status
- Student to be escorted to visitor center to be picked up by school personnel
- Information will be provided to parent/guardian including:
 - requirement for seeing health care provider
 - Return to school protocol after temperature of 100.0 or greater (14 days temperature free without medication)

8. Cincinnati Central requires all visitors, guests, contractors, and vendors entering the school to follow all Cincinnati Central health screening guidelines.

Essential visits only:

- All visitors, guests, contractors, and vendors will be screened, including temperature and questionnaire prior to granting access to the building.
- Temperature greater than 100.0 or “yes” to any question on questionnaire will be denied entry to building

9. Each school and/or district reopening plan has a written protocol to instruct parents/guardians to observe for signs of illness in their child that require staying home from school.

Written instruction to parents regarding the signs and symptoms of illness which require them to stay home.

- Signs and symptoms of illness:
 - Fever (100.0 or higher) or chills
 - Cough
 - Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
- symptoms may appear 2-14 days after exposure to the virus.

10. Each school and/or district reopening plan has written protocol and appropriate signage to instruct staff and students in correct hand and respiratory hygiene.

Cincinnati Central School will ensure all students are taught or trained how to follow new COVID-19 protocols safely and correctly, including but not limited to hand hygiene, proper face cover wearing, and respiratory hygiene.

Cincinnati central School will encourage all students, faculty, staff, and visitors through verbal and written communication (e.g., signage) to adhere to CDC and DOH guidance regarding the use of PPE, specifically acceptable face coverings, when a social distance cannot be maintained

- Each classroom will have CDC Wash Your Hands signage by every water outlet
- Elementary signage
- Secondary Signage
- Student and staff bathrooms will have CDC Wash Your Hands signage
- All entrances will have CDC face covering signage as students, staff and visitors entering the buildings
- Each classroom will have CDC face covering signage as you enter and exit the classroom
- CDC face mask signage will be placed conspicuously throughout the building hallways, stairways, instruction areas, offices and non social distancing conforming areas
- Remind staff and students that it is important that students and staff cover their mouths or noses with a tissue when coughing or sneezing and dispose of the tissue appropriately
- A supply of tissues and no touch/floor pedal trash cans will be available in each room when feasible. If no tissue is available, using the inside of the elbow (or

shirtsleeve) to cover the mouth or nose is preferable to using the hands. Always perform hand hygiene after sneezing, coughing and handling dirty tissues or other soiled material

Cincinnati Central School will require that all individuals in school facilities and on school grounds must be prepared to put on a face covering if another person unexpectedly cannot socially distance. All students and staff members must wear cloth face coverings:

- Whenever they are within 6 feet of someone
- In hallways
- In restrooms
- In other congregate settings, including buses.

Cincinnati Central School will provide acceptable face covering to employees (and students if they forget their own) and have an adequate supply in case of need for replacement. Employees with healthcare provider documentation stating they are not medically able to tolerate face covering cannot be required to do so. Face coverings may be challenging for students (especially younger students) to wear in all-day settings such as school, so scheduling mask breaks is important.

Face coverings will not be required for persons that are:

- Younger than 2 years old
- Students where such covering would impair their health or mental health, or where such covering would present a challenge, distraction, or obstruction to education services and instruction
- Anyone who has trouble breathing or is unconscious
- Anyone who is incapacitated or otherwise unable to remove the cloth face covering without assistance.

Cincinnati Central Schools will provide instruction to students, parents/guardians and staff, contractors and vendors on:

- The proper way to wear face coverings
- Washing hands before putting on and after removing their face covering
- Proper way to discard disposable face coverings
- The importance of routine cleaning of reusable face coverings
- Face coverings are for individual use only and should not be shared

Additionally, communications will be provided in the language(s) spoken at home among families and throughout the school community.

Hand Hygiene Plan

Cincinnati Central built in staggered hand washing times for students and staff. We have also increased hand hygiene to include:

- Traditional hand washing (with soap and warm water, lathering for a minimum of 20 seconds), which is the preferred method;
- Use of alcohol-based hand sanitizers (60% alcohol or greater)
- We have obtained a script from our School Physician, Dr. Rahner, for students to use hand sanitizer with an alcohol content greater than 60%.
 - Elementary will have supervised use of hand sanitizer
- We provide hand sanitizer throughout common areas (e.g. entrances, cafeteria), near high touch surfaces, and use touch free dispensers when able;
- We have signage near hand sanitizer indicating visibly soiled hands should be washed with soap and water; and
- Any staff or students unable to use hand sanitizer are permitted to wash their hands with soap and water.

Cincinnati Central provides the following:

- Facilities and supplies for hand washing including soap and water;
- Paper towels and touch free paper towel dispensers where feasible, air dryers have been removed and disabled from all buildings;
- No-touch trash cans;
- Alcohol-based hand sanitizers with at least 60% alcohol or disinfectant hand wipes;
- Time in the schedule to allow for frequent hand washing; and
- Promotion of proper hand washing before meals, after recess or physical education, before and after removing PPE, and other times, as appropriate.

All students and staff should wash hands, as follows:

- Upon entering the building and each classroom;
- After using shared objects or surfaces (e.g. electronic devices, musical instruments, writing utensils, tools, toys, desks or table tops);
- Before and after snacks and lunch;
- After using the bathroom;
- After helping a student with toileting;
- After sneezing, wiping or blowing nose, or coughing into hands;
- Upon coming in from outdoors; and
- Anytime hands are visibly soiled.

Respiratory Hygiene Plan

- All students and staff should cover their mouths or noses with a tissue when coughing or sneezing and dispose of the tissue appropriately. Cincinnati Central provides tissues in each classroom and common areas.
- No touch/floor pedal trash receptacles are available in each room and common area.
- If no tissue is available, using the inside of the elbow (or shirtsleeve) to cover the mouth or nose is preferable to using the hands.

- Students and staff should always perform hand hygiene after sneezing, coughing and handling dirty tissues or other soiled material.

11. Cincinnati Central School will ensure all students are taught or trained how to follow new COVID-19 protocols safely and correctly, including but not limited to social distancing.

Cincinnati Central School will ensure that student groupings are as static as possible by having the same group/cohort of students stay together.

- The size of groups/cohorts of students are determined by the number of students who can be in each classroom while maintaining 6 feet social distancing.
- The district will divide up student entry points rather than funneling all students through the same entry space, to limit the amount of close contact between students in high-traffic situations and times. We will utilize the 3 entrances into the small gym for students who walk or get dropped off by a parent. Students in grades UPK and Kindergarten will enter through the Visitor Center. Temperature checks will be completed here. Students getting off buses will enter through the Senior Lounge entrance or into the Grade 3 entrance. Buses will be staggered for arrival and students will maintain social distancing while wearing masks.
- The school will follow all safety requirements when considering the use of other entrances and ensure that all entrances are monitored and are locked after use
- Making arrival schedule changes for students who walk or are dropped off at school by a parent or caregiver will be observed
- Designated areas for student drop-off and pick-up will be monitored to the greatest extent possible. Parents will not have access to the building unless by appointment.
- Reduce in-school movement where possible by keeping students within a defined area or classroom and modifying class schedules or class transitions using these recommendations:
 - If possible, have the same cohort of students with the same teacher each day
 - Special area teachers (e.g., music, art, physical education) will go to individual classrooms versus rotating all students through a shared space that is not able to be cleaned with each new use. Whenever possible, hold physical education and music classes outside and encourage students to spread out
 - Restroom use will be monitored and staggered throughout the day. Bathrooms will be monitored by staff to ensure social distancing, that it is clean, and students are washing hands after use.
- Desks (including teachers) will face in the same direction rather than facing each other to reduce transmission caused by virus-containing droplets (e.g., from talking, coughing, sneezing)

- Windows will be open to improve ventilation. Windows will not be opened if there is a health or safety risk (e.g., allergies, or potential fall)
- Individual student belongings will be separated and there will not be shared supplies.
- Visual aids will be used (e.g., painter's tape, stickers, posters, cones etc.) to illustrate traffic flow and appropriate spacing to support social distancing
- Students will eat outside or in their classrooms for grades UPK - 4. Students in grades 5 - 12 will eat in their classrooms, outside, or in the cafeteria maintaining social distancing. The small gym may also be utilized when weather conditions necessitate the additional space.
- Gatherings in small spaces (e.g., elevators, faculty offices) will be limited, unless all individuals in such space are wearing acceptable face coverings.
- Playgrounds may continue to be used when proper safeguards are in place. Playground use will be rotated among grades UPK - 2 daily.
- A distance of twelve feet in all directions will be maintained between individuals participating in activities requires projecting the voice (e.g., singing), playing a wind instrument, or aerobic activity. The Auditorium will be used for band and choral practice each day with assigned seats.
- Athletics and all fine arts performances are currently postponed awaiting additional guidance from New York State Education Department.
- All visitors will have to have an appointment to gain access to the building. We will utilize Google meets or Zoom for meetings with parents and other persons.

Students with special needs or students who are medically fragile may not be able to maintain social distancing, hand or respiratory hygiene, or wear a face covering or mask. As a result, we will work with parents/ guardians to work with their child's healthcare providers so that an informed decision can be made on how best to meet the child's needs at school while protecting their health and safety.

Cincinnati School will assist with transitioning these students back to school with the planning and coordination of:

- school health services personnel
- special education personnel
- pupil personnel services
- Administration

Being aware that such families are already under significant stress and COVID-19 has made their situations more critical. Alternate plans created in consultation with school health personnel on how to meet the needs of the child while keeping social distancing may include:

- Additional PPE for staff caring for such students
- Assigning only one staff member to care for the student
- Decreased students in a classroom, alternating schedules, and provision of related services to an individual instead of group setting

Restricted Areas

Cincinnati Central restricts the use of classrooms and other places where students, faculty, and staff gather (e.g., lockers, cubbies, entryways, hallways), so that individuals can be socially distanced. We are limiting gathering in small spaces (e.g., elevators, faculty offices) by more than one individual at a time, unless all individuals in such space are wearing acceptable face coverings;

Cincinnati Central will utilize playgrounds when proper safeguards are in place. In elementary school settings, we are staggering playground use rather than allowing multiple classes to play together. We will have students wash hands before and after touching play structures and keep 6 feet of space from other children as much as possible.

We have ensured that a distance of twelve feet in all directions is maintained between individuals while participating in activities that require projecting the voice (e.g., singing), playing a wind instrument, or aerobic activity.

We have postponed all athletic activities, concerts, and performances until these are approved by the New York State Education Department, the Department of Health, or the Cortland Health Department.

We are limiting visitors in the following ways:

- Parents and vendors will have to have an appointment in order to gain access to our school.
- A Visitor's Log is maintained at our single point of entry and visitors must be escorted into the building as a part of our typical routine. If visitors or vendors are on the approved list, they will be required to wear masks until they reach their destination. If applicable, visitors will be able to remove their masks if social distancing can be established and maintained.

12. Our district reopening plan has written protocol detailing how the district/school will provide accommodations to all students and staff who are at high risk or live with a person at high risk.

EX: CCSD staff provides accommodations to students in the school community that are medically vulnerable or high-risk groups.

- We provide the following options:
- For families with special needs or students who are medically fragile and may not be able to maintain social distancing, hand or respiratory hygiene, or wear a face covering or mask. It is important for parents/ guardians to work with their child's healthcare providers so that an informed decision can be made on how best to meet the child's needs at school while protecting their health and safety. Please

- We will coordinate with:
 - school health services personnel
 - special education personnel
 - pupil personnel services and
 - administration
- If you are choosing to not send your child to school, we will provide remote instruction per New York State Education Department Reopening Guidance. Please contact your child's principal if this is your intent.

13. Cincinnati Central reopening plan has a written protocol requiring all employees, adult visitors, and students to wear a cloth face covering whenever social distancing cannot be maintained.

Cincinnati Central follows [OSHA COVID-19 guidance for its employees](#) along with the [guidance put forth by the CDC](#) in partnership with our local health department.

Cincinnati Central is ensuring we have adequate supplies of PPE for staff and students by working through cooperative purchases through our BOCES and collaborating with our local health department.

Cincinnati Central requires all individuals in school facilities and on school grounds to put on a face covering if another person unexpectedly cannot socially distance. All students and staff members must wear cloth face coverings:

- Whenever they are within 6 feet of someone
- In hallways;
- In restrooms; and
- In other congregate settings, including buses.
- Anytime they are in motion

Cincinnati Central provides acceptable face covering to employees (and students if they forget their own) and we have an adequate supply in case of need for replacement per Executive Order 202.16.

Cincinnati Central does allow employees to wear their own acceptable face covering. For employees with healthcare provider documentation stating they are not medically able to tolerate face covering, we cannot be required to do so.

Face coverings may be challenging for students (especially younger students) to wear in all-day settings such as school,

Face coverings should not be placed on:

- Children younger than 2 years old;
- Students where such covering would impair their health or mental health, or where such covering would present a challenge, distraction, or obstruction to education services and instruction;
- Anyone who has trouble breathing or is unconscious; or
- Anyone who is incapacitated or otherwise unable to remove the cloth face covering without assistance.

Cincinnati Central provides instructions to all students, parents/guardians and staff, contractors and vendors on:

- The proper way to wear face coverings;
- Washing hands before putting on and after removing their face covering;
- Proper way to discard disposable face coverings;
- The importance of routine cleaning of reusable face coverings; and
- Face coverings are for individual use only and should not be shared.

Please note: Students and staff may use alternate PPE (i.e., face coverings that are transparent at or around the mouth) for instruction or interventions that require visualization of the movement of the lips and/or mouths (e.g., speech therapy). These alternate coverings may also be used for certain students (e.g., hearing impaired) who benefit from being able to see more of the face of the staff member. We will provide face shields as requested by staff during these activities.

14. Each school and/or district reopening plan has plan for obtaining and maintaining adequate supplies of cloth face coverings for school staff, students who forget their masks,

Cincinnati Central is ensuring we have adequate supplies of PPE by working through cooperative purchases through our BOCES and collaborating with our local health department. Furthermore, masks will be available on all school owned transportation, at all entrances accessed by staff and students.

15. Each school and/or district reopening plan has written protocol for actions to be taken if there is a confirmed case of COVID-19 in the school.

Cincinnati Central requires students and staff with symptoms of illness must be sent to the health office. Our nurse, Megan Potter, is available to assess individuals.

If a school nurse is not available, Cincinnati Central staff will have to isolate and dismiss any student or staff member who has a fever or other symptoms of COVID-19 that are not explained by a chronic health condition for follow up with a health care provider.

Cincinnati Central follows Education Law § 906, which provides whenever...a student in the public schools shows symptoms of any communicable or infectious disease reportable under the public health law that imposes a significant risk of infection of others

in the school, he or she shall be excluded from the school and sent home immediately, in a safe and proper conveyance. The director of school health services shall immediately notify a local public health agency of any disease reportable under the public health law⁷. The director of school health services, or other health professionals acting upon direction or referral of such director, may take such evaluations of teachers and any other school employees, school buildings and premises as, in their discretion, they may deem necessary to protect the health of the students and staff.

Effective February 1, 2020, the 2019-Novel Coronavirus was added to the Public Health Law as a significant threat to the public health, and the NYS Commissioner of Health designated 2019-Novel Coronavirus as a communicable disease under 10 NYCRR Section 2.1 direction or referral of such director, may make such evaluations of teachers and any other school employees, school buildings and premises as, in their discretion, they may deem necessary to protect the health of the students and staff.

Cincinnati Central requires school staff immediately report any illness of students or staff to the school nurse or other designated school staff. Such reports are made in compliance with FERPA, and Education Law 2-d.

Students suspected of having COVID-19 awaiting transport home by the parent/guardian will be isolated in a room or area separate from others, with a supervising adult present utilizing appropriate PPE. Multiple students suspected of COVID-19 may be in this isolation room if they can be separated by at least 6 feet.

Cincinnati Central will take the following steps:

- Closing off areas used by a sick person and not using these areas until after cleaning and disinfection has occurred;
- Opening outside doors and windows to increase air circulation in the area.
- Waiting at least 24 hours before cleaning and disinfection. If waiting 24 hours is not feasible, wait as long as possible;
- Clean and disinfect all areas used by the person suspected or confirmed to have COVID-19, such as offices, classrooms, bathrooms, lockers, and common areas.
- Once the area has been appropriately cleaned and disinfected it can be reopened for use.
- Individuals without close or proximate contact with the person suspected or confirmed to have COVID-19 can return to the area and resume school activities immediately after cleaning and disinfection.
- Cincinnati Central refers to the DOH's "Interim Guidance for Public and Private Employees Returning to Work Following COVID-19 Infection or Exposure" for information on "close and proximate" contacts
- If more than seven days have passed since the person who is suspected or confirmed to have COVID-19 visited or used the facility, additional cleaning

and disinfection is not necessary, but routine cleaning and disinfection should continue.

- If a separate room is not available, Cincinnati Central will ensure that person keeps at least a 6-foot distance between ill students. If they cannot be isolated in a separate room from others, we will provide a facemask (e.g., cloth or surgical mask) to the student if the ill person can tolerate wearing it and does not have difficulty breathing,

To prevent the possible transmission of the virus to others while waiting for transportation home. The following steps will be taken:

- Students should be escorted from isolation area to the parent/guardian;
- The parent or guardian will be instructed to call their health care provider, or if they do not have a health care provider, to follow up with a local clinic or urgent care center;
- Symptomatic students or staff members will follow CDC's Stay Home When You Are Sick guidance unless otherwise directed by a healthcare provider or the local department of health.
- If the student or staff member has emergency warning signs such as trouble breathing, persistent pain or pressure in the chest, new confusion, inability to arouse, bluish lips or face, Cincinnati Central will call 911 and notify the operator that the person may have COVID-19;
- Cincinnati Central staff is aware of the symptoms of Multisystem Inflammatory Syndrome in Children (MIS-C) associated with COVID-19 which is a serious condition associated with COVID-19 in children and youth. Employees should notify the parent/guardian if their child shows any of the following symptoms and recommend the child be referred for immediate follow up with a healthcare provider:

- Fever
- Abdominal pain
- Vomiting
- Diarrhea
- Neck pain
- Rash
- Bloodshot eyes
- Feeling extra tired

Staff must call for emergency transport (911) following district policies for any student showing any of these emergency warning signs of MIS-C or other concerning signs:

- trouble breathing
- pain or pressure in the chest that does not go away
- new confusion

- inability to wake or stay awake
- bluish lips or face
- severe abdominal pain

If a student or staff member reports having tested positive for COVID-19, school administrators or his/her designee should notify the local health department to determine what steps are needed for the school community.

Return to School after Illness

Cincinnati Central follows CDC guidance for allowing a student or staff member to return to school after exhibiting symptoms of COVID-19. If a person is not diagnosed by a healthcare provider (physician, nurse practitioner, or physician assistant) with COVID-19 they can return to school:

- Once there is no fever, without the use of fever reducing medicines, and they have felt well for 24 hours;
- If they have been diagnosed with another condition and have a healthcare provider written note stating they are clear to return to school.
- If a person is diagnosed with COVID-19 by a healthcare provider based on a test or their symptoms or does not get a COVID-19 test but has had symptoms, they should not be at school and should stay at home until:
- It has been at least ten days since the individual first had symptoms;
- It has been at least three days since the individual has had a fever (without using fever reducing medicine); and
- It has been at least three days since the individual's symptoms improved, including cough and shortness of breath

COVID-19 Testing

Cincinnati Central complies with CDC guidance and we do not conduct COVID-19 testing or require testing or antibody testing of students or staff members. The decision of whether a test needs to be conducted should be determined by a healthcare provider or the local department of health.

Contact Tracing

Cincinnati Central cooperates with state and local health department contact tracing. We assist public health departments in knowing who may have had contact at school with a confirmed case by:

- Keeping accurate attendance records of students and staff members;
- Ensuring student schedules are up to date;
- Keeping a log of any visitors which includes date, time and where in the school they visited; and
- Assisting local health departments in tracing all contacts of the individual at school in accordance with the protocol, training, and tools provided through the New York State Contact Tracing Program.
- Maintaining confidentiality as required by federal and state laws and regulations.

School staff should not try to determine who is to be excluded from school based on contact without guidance and direction from the local department of health.

16. Each school and/or district reopening plan has written protocol that complies with DOH and CDC guidance for the return to school of students and staff following a positive screen for COVID-19 symptoms, illness or diagnosis of confirmed case of COVID-19 or following quarantine due to contact with a confirmed case of COVID-19. Return to school will be coordinated with the local health department.

Cincinnati Central collaborates with our local health department to determine the parameters, conditions or metrics (e.g., increased absenteeism or increased illness in school community) that will serve as early warning signs that positive COVID-19 cases may be increasing beyond an acceptable level. Lisa Perfetti, of the Cortland Health Department will work with our school nurse and Superintendent to determine if a child or staff member can return to school based on quarantine or isolation status as well as guidance from the New York State Department of Health.

Cincinnati Central administrators will consider closing school if absentee rates impact the ability of the school to operate safely. Cincinnati Central may choose to modify operations prior to closing to help mitigate a rise in cases. Cincinnati Central will consult our medical director, Dr. Douglas Rahner and/or the local department of health when making such decisions.

17. Each school and/or district reopening plan has written protocol to clean and disinfect schools following CDC guidance.

Cincinnati Central School will follow the CDC Reopening Guidance for Cleaning and Disinfection with specific guidance for schools along with the Cleaning and Disinfection Decision Tool to aid in determining what level of cleaning and/or disinfection is necessary. School wide

cleaning will include classrooms, restrooms, cafeterias, libraries, playgrounds, and busses. The guidance provides a general framework for cleaning and disinfection practices.

At a minimum, Cincinnati Central cleaning includes classrooms, restrooms, cafeteria, library, playground, hallways, buses, or any area where students or staff utilize.

To help with cleaning and disinfection Cincinnati Central staff will perform the following:

- Keep accurate attendance records of students and staff members;
- Ensuring student schedules are up to date;
- Perform normal routine cleaning with soap and water will decrease how much of the virus is on surfaces and objects, which reduces the risk of exposure;
- Provide disinfection using US Environmental Protection Agency (EPA)-approved disinfectants against COVID-19.
- Provide frequent disinfection of surfaces and objects touched by multiple people;
- We will keep all disinfectants out of the reach of children;
 - Classrooms
 - Teachers clean and disinfect high touch areas throughout the day
 - Custodians clean and disinfect rooms daily
 - Health Office
 - Clean and disinfect health cots regularly (after each student use)
 - Cover treatment tables and use pillow protectors
 - Discard or launder coverings after each use
 - Lunchrooms
 - Clean and disinfect lunch tables after every change of classes (at least once daily)
 - Athletic Rooms
 - Disinfect shared environmental surfaces such as wrestling mats or strength-training equipment daily
 - Disinfect mats and other high-use equipment after every class
 - Other Frequently Touched Surfaces clean and disinfect after every class
- Cincinnati Central will maintain logs that include the date, time, and scope of cleaning and disinfection in a facility or area.

*Cleaning plans include considerations regarding the safety of custodial staff and other people who are carrying out the cleaning or disinfection. PPE is supplied by the District

for all cleaning staff.

Cincinnati Central will clean high touch surfaces frequently throughout the day.

Examples of high touch surfaces include:

- Tables;
- Doorknobs;
- Light switches;
- Countertops;
- Handles;
- Desks;
- Phones;
- Keyboards and tablets;
- Toilets and restrooms; and
- Faucets and sinks.

Students should not be present when disinfectants are in use and should not participate in cleaning and/or disinfection activities.

Filters in air handlers will be changed every 60 days

Windows will be opened to increase airflow as recommended in DOH guidelines.

Cincinnati Central School students will not share wind musical instruments. They will be issued individual instruments, if requiring a school-owned instrument. They will rent or buy their own, if the family chooses, and will not share it with any other student. Band rehearsals will be conducted outside or in the auditorium where 12 feet of separation can be established and maintained.

Cincinnati Central custodial staff cleans playgrounds per CDC guidance:

- High touch surfaces made of plastic or metal, such as grab bars and railings will be cleaned routinely
- Shared athletic/gym equipment (e.g., balls, protective gear) will be cleaned between use per manufacturer's directions.

School Health Office Cleaning

School health office cleaning must occur after each use of:

- Cots;
- Bathroom; and
- Health office equipment (e.g. blood pressure cuffs, otoscopes, stethoscopes, etc.) should be cleaned following manufacturer's directions.

Disposable items should be used as much as possible including:

- Disposable pillow protectors; or
- Disposable thermometers, or disposable thermometer sheaths or probes, and disposable otoscope specula.

18. Cincinnati Central School will conduct the required safety drills in accordance with Education Law § 807. Cincinnati Central School will conduct 8 evacuation and 4 lockdown drills in the 20-21 school year. When planning these drills, consideration should be given to how a school may modify their drill procedures to minimize risk of spreading infection. Conducting drills is an important part of keeping students and staff safe in an emergency, however, steps will be taken to minimize the risk of spreading infection while conducting drills. As such, it may be necessary for schools to conduct drills in the 2020-21 school year using protocols that are different than they are used to. Regardless of the modification used when conducting a drill, students will be instructed that if it was an actual emergency that required evacuation or lockdown, the most imminent concern is to get to safety; maintaining social distancing in an actual emergency that requires evacuation or lockdown may not be possible and should not be the first priority.

Modifications to evacuation drill protocols will include:

- Conducting drills on a “staggered” schedule, where classrooms evacuate separately rather than all at once, and appropriate distance is kept between students to the evacuation site. Staggering by the classroom, minimizes contact of students in hallways, stairwells, and at the evacuation site. If conducting drills using a modified procedure, it is required that the drill be conducted with all students in the school building on that school day, it may be necessary to do so during a class period that is extended for this purpose
- If schools re-open with a “hybrid” in-person model, such as one where students attend school alternate school weeks to reduce the occupancy of the school building, schools must be certain that all students are receiving instruction in emergency procedures, and participating in drills while they are in attendance in-person.

Modifications to Lockdown Drills will include:

- Conduct lockdown drill in classroom setting while maintaining social distancing and using masks
- Conduct lockdown drills in the classroom without “hiding”/ “sheltering” but provide an overview of how to shelter or hide in the classroom.

19. Each school and/or district reopening plan has a written plan for district/school run before and aftercare programs (or, for charter schools, as required by the school’s charter).

There is no before or after school care program in Cincinnati.

20. Each school and/or district reopening plan must designate a COVID-19 safety coordinator (administrator) whose responsibilities include continuous compliance with all aspects of the school's reopening plan, as well as any phased-in reopening activities necessary to allow for operational issues to be resolved before activities return to normal or "new normal" levels.

► Facilities

1. Each school and/or district reopening plan which include changes or additions to facilities must comply with the requirements of the 2020 New York State Uniform Fire Prevention and Building Code (BC) and the State Energy Conservation Code and submit all changes to OFP.

Cincinnati Central School will conform to the requirements of the 2020 New York State Fire Prevention and Building Code and the State Energy Conservation Code and submit any changes to the Office of Facilities Planning.

2. Each school and/or district reopening plan must ensure compliance with the 2020 Building Condition Survey and Visual Inspection, where applicable.

Cincinnati Central School will comply with the scheduled 2020 Visual Inspection and the 2021 Building Condition Survey.

3. Each school and/or district reopening plan must provide provisions to conduct the Lead-In-Water Testing as required by NYS DOH regulation 67-4.

As required by NYSDOH regulation 67-4, Cincinnati Central School will complete the Lead-In-Water Testing, conforming to regulation set by NYSDOH, by december 31, 2020.

4. Each school and/or district reopening plan must ensure all existing and new Alcohol-based Hand-Rub Dispensers which are installed in any locations are in accordance with FCNYS 2020 Section 5705.5.

Cincinnati Central School will ensure that any alcohol based hand sanitizer will conform according to FCNYS 2020 Section 5705.5.

5. Each school and/or district reopening plan which includes the installation of dividers in classrooms, libraries, cafeterias, auditoriums, gymnasiums, doors, and other points of congregation will ensure the submission of detailed floor plans to OFP for review.

Cincinnati Central School will submit a plan to the Office of Facilities Planning if there are any installations of dividers in classrooms, libraries, cafeterias, auditoriums, gymnasiums, doors and other points of congregation. Currently, there is not a need to install said dividers.

Cincinnati Central School District Reopening Plan

6. Each school and/or district reopening plan must ensure that all new building construction and temporary quarter projects will be submitted to OFP for a full code review.

Cincinnati does not currently have any new building construction planned.

7. Each school and/or district reopening plan which includes new facilities for leasing must provide a plan to consult with OFP for a preliminary evaluation.

Cincinnati Central School does not have plans to lease any additional spaces.

8. Each school and/or district reopening plan which includes the temporary or permanent use of Tents must provide plans adhering to the BCNYS.

Cincinnati Central School does not have plans to use any temporary or permanent tents for additional space.

9. Each school and/or district reopening plan must ensure that the existing or altered number of toilet and sink fixtures meet the minimum standards of the BCNYS.

Cincinnati Central School will be reducing the number of toilet fixtures in the building in order to facilitate frequent cleaning and social distancing. However, the minimum number of toilet fixtures that must be available for use in a building is established in the building code and the district will conform to the NYSED Building Code.

- If the building occupancy is reduced using partial remote learning or reductions, the school will be better able to use social distancing in bathrooms by only allowing one person to occupy it at a time.
- Bathroom doors will have occupied signage on them to allow students and staff to know if the capacity has been reached
- Only one urinal per bathroom will be used, others will be disabled with signage
- Frequent handwashing is a key component to avoiding the spread of COVID-19, so sinks and soap will be available to building occupants at all times. Plastic separators will be installed in between sinks if social distancing is not an option
- If any bathrooms are completely closed, a plan will be sent to OFP for review

10. Each school and/or district reopening plan must ensure that each building provides one drinking fountain per one hundred occupants or provide a written plan for a reasonable alternate source of drinking water.

Cincinnati Central School will disable all drinking fountains available, and provide bottle fill stations in order to facilitate frequent cleaning and the transmission of COVID-19.

- One bottle fill station will be provided for each one hundred occupants.
- Cafeteria will have bottled drinking water or water in disposable cups.

11. Each school and/or district reopening plan must provide written plans on how to maintain

adequate, code required ventilation (natural or mechanical) as designed.

Cincinnati Central School will maintain adequate, code required, ventilation by:

- Increasing the fresh air ventilation rate to the extent possible to aid in maintaining a healthy indoor air quality
- Installing a higher efficiency air filter where applicable
- Changing filters every 60 days
- Recommend to staff to use window ventilation when safe and possible

12. Each school and/or district reopening plan must ensure that all project submissions only dedicated to “COVID-19 Reopening” will be labeled as such.

Cincinnati Central School will only submit projects to OFP dedicated to “COVID-19 Reopening” labeled such as.

13. Each school and/or district reopening plan which includes the use of plastic separators must comply with the 2020 BCNYS Section 2606.

Cincinnati Central Schools will only use those plastic separators that conform to the 2020 BCNYS Section 2606 regulations

Child Nutrition

1. Each school and/or district reopening plan must provide all students enrolled in the SFA with access to school meals each school day. This must include students in attendance at school and students learning remotely.

All students will have access to reimbursable meals that are compliant with the School Breakfast Program and the National School Lunch Program.

- These meals will be prepared and served in accordance with all local health department and CDC guidelines
- Students will be discouraged from sharing any utensils or food items.
- Measures will be taken to safeguard students with food allergies.
- Students will be encouraged to wash hands before and after meal service.

- Food service staff will discontinue the use of peanut butter or peanut products for meals delivered to classrooms
- Parents will be asked to exclude peanut butter from meals brought into the classroom from home
- Food service staff delivering meals will have coded classroom rosters that display any known food allergens of each student
- School nurses will provide teachers with a listing of student allergies
- Alternate food items will be substituted per doctors notes and allergy indication, i.e. Lactaid replaced for milk, gluten free bread used for sandwiches

5. Cafeteria staff and maintenance staff will follow protocols and procedures that require cleaning and disinfection prior to the next group of students arriving for meals, if served in the same common area in the cafeteria or outside.

► Transportation

1. Each school and/or district reopening plan must ensure all buses (conforming and non-conforming to Federal Motor Carrier Safety Standards, as well as type A, C or D) which are used every day by districts and contract carriers will be cleaned/disinfected once a day.

- Head bus driver, Jen Fox will explicitly state that staff **MAY NOT** possess hand sanitizer and staff will receive written notification during annual staff training.

5. Each school and/or district reopening plan will require that school bus drivers, monitors, attendants and mechanics must wear a face covering along with optional face shield.

- All staff will be provided with PPE including face masks, gloves, and face shields (to be worn in conjunction with a mask).

6. Each school and/or district reopening plan requires that transportation staff (drivers, monitors, attendants, mechanics and cleaners) will be trained and provided periodic refreshers on the proper use of personal protective equipment and the signs and symptoms of COVID-19.

- All drivers, mechanics, and transportation aides will receive training on September 3, 2020, on the proper use of personal protective equipment and the signs and symptoms of COVID-19 as well as during the planned refresher training on November 3, 2020, January 29, 2021 and March 15, 2021.

7. Each school and/or district reopening plan requires that transportation staff (drivers, monitors, attendants, mechanics and cleaners) will be trained and provided periodic refreshers on the proper use of social distancing.

- All drivers, mechanics, and transportation aides will receive training on September 3, 2020, on the proper use of personal protective equipment and the signs and symptoms of COVID-19 as well as during the planned refresher training on November 3, 2020, January 29, 2021 and March 15, 2021.

8. Each school and/or district reopening plan requires that transportation departments/carriers will need to provide Personal Protective Equipment such as masks and gloves for drivers, monitors and attendants in buses.

- All staff will be provided with PPE including face masks, gloves, and face shields (to be worn in conjunction with a mask).

9. Each school and/or district reopening plan ensures hand sanitizer will be provided for all staff in their transportation locations such as dispatch offices, employee lunch/break rooms and/or bus garages.

- There is a supply of hand sanitizer at the Transportation Facility currently as well as in storage provided by the Cortland County Health Department. Additional stock has been ordered.

10. Each school and/or district reopening plan requires that drivers, monitors and attendants who must have direct physical contact with a child must wear gloves.

- All staff will be provided with PPE including face masks, gloves, and face shields (to be worn in conjunction with a mask). Staff will receive training on the necessity of wearing gloves when working with children as well as the proper removal of gloves at the end of the shift.

11. Each school and/or district reopening plan requires that school bus drivers, monitors, attendants and mechanics shall perform a self-health assessment for symptoms of COVID-19 before arriving to work.

- Staff screening and questionnaire:
 - at home via an app downloaded to a phone or tablet prior to coming to school created by OCM BOCES
 - Screening to include temperature and questionnaire DAILY prior to staff coming to work

12. Each school and/or district reopening plan requires that students must wear a mask on a school bus if they are physically able.

- Students will be required to wear a mask in order to board the bus unless they are approved

by the District as not being physically able to. Masks will be provided by the District for any student in need.

13. Each school and/or district reopening plan ensures that students who do not have a mask will NOT be denied transportation.

- Students will be required to wear a mask in order to board the bus unless they are approved by the District as not being physically able to. Masks will be provided by the District for any student in need. A student who refused to wear a mask will be seated in the front of the bus or alternate transportation will be provided.

14. Each school and/or district reopening plan requires that students who do not have masks must be provided one by the district.

- Masks will be provided by the District for any student in need.

15. Each school and/or district reopening plan ensures that students with a disability which would prevent them from wearing a mask will not be forced to do so or denied transportation.

- Students will be required to wear a mask in order to board the bus unless they are approved by the District as not being physically able to. This will be determined by the Director of Pupil and Personnel Services as well as the child's parent or guardian and their primary physician. Furthermore, they will receive priority seating on the bus or be provided with alternate transportation.

16. Each school and/or district reopening plan requires students to be trained and provided periodic reminders on the proper use of personal protective equipment and the signs and symptoms of COVID-19.

17. Each school and/or district reopening plan requires that students will be trained and provided periodic reminders on the proper use of social distancing.

18. Each school and/or district reopening plan requires that if the school district is in session remotely or otherwise, pupil transportation must be provided to nonpublic, parochial, private, charter schools or students whose Individualized Education Program have placed them out of district whose schools are meeting in conducting in- person session education when/if the district is not.

- Students attending BOCES programs and Charter Schools will receive daily transportation and they are obligated to follow district protocol including:
 - Masks will be worn on buses,
 - Students will have assigned seats,
 - Students will sit in a seat by themselves or may be required to sit with someone who

- lives in their household,
- Will not be able to eat or drink on the bus,
- Staggered arrival and dismissal.
- Parents will be encouraged to drop off and pick up their children.

Social Emotional Well-Being

1. Each school and district ensures that district-wide and building-level comprehensive developmental school counseling program plans, developed under the direction of certified school counselor(s), are reviewed and updated to meet current needs.

Our comprehensive counseling plan guides the work of our school counselors in supporting

students and families during times of transition, facilitating communication about resources and expectations, and guidance to individuals as they plan their path to success. Students will meet with school counselors annually to discuss their progress in the current school year and make plans for the future, in light of the student's long term goals. This provides students with an opportunity to build a relationship with the school counselor and obtain support for goal setting and action plans. These conversations will include discussion of the impact of changes to Regents examinations, graduation requirements, and course completion that have taken place or may arise during the school year.

Our district comprehensive developmental counseling plan was updated to feature additional student supports, both universally and for students who demonstrate a higher level of need. The plan outlines the process for referrals to mental health resources, both in district and in the community. The plan also provides for additional Social and Emotional Learning opportunities through the Positivity Project and peer mentoring programs.

2. Each school and/or district establishes an advisory council, shared decision-making, school climate team, or other collaborative working group comprised of families, students, members of the board of education, or school's board, school building and/or district/charter leaders, community-based service providers, teachers, certified school counselors, and other pupil personnel service providers including school social workers and/or school psychologists, to inform the comprehensive developmental school counseling program plan.

Our district utilizes a Student Support Team consisting of school counselors, school social workers, building principals, and the director of pupil personnel services to identify the needs of individual students and groups of students informing the district comprehensive developmental school counseling plan. The school psychologist, teachers, service providers, families, and students are consulted for input to guide revisions to the plan on an annual basis. The Student Support Team meets monthly, with two of those meetings dedicated to reviewing and revising the comprehensive developmental school counseling plan .

3. Each school and/or district reopening plan addresses how the school/district will provide resources and referrals to address mental health, behavioral, and emotional support services and programs.

Tier 1: Practices for all students:

- Positivity Project - Students at all grade levels will engage with character education mini-lessons on defining character traits within a framework that promotes building positive relationships.
- Universal Screening - The district will implement the use of a universal screening tool to measure social, emotional, and behavioral functioning. The data gathered, with parental consent, will be used to identify needs to be addressed as part of the whole school counseling plan and character education, as well as, to identify students who may need Tier 2 supports that may be less visible. In addition, this tool will be used to monitor the

progress and growth of students participating in Tier 2 social and emotional learning support.

- Annual Review of Progress and Career Plan - Students in grades 6-12 will meet with school counselors annually to discuss their progress in the current school year and make plans for the future, in light of the student's long term goals. This provides students with an opportunity to build a relationship with the school counselor and obtain support for goal setting and action plans.
- Provide information about community resources - Students will receive an age-appropriate introduction to health and human services available in their community and how to access them. This information will be developed by school counselors and social workers. Referrals to these services are made by our school social workers and counselors in collaboration with families, typically for students in crisis or those in need of a higher level of professional care identified by our multi-tiered system of Social and Emotional Learning support.
- Multiple daily opportunities for Social and Emotional Learning practice - Students will have the opportunity to engage with social and emotional learning activities in an age-appropriate way. Hybrid models will maintain a schedule of class lessons on the same schedule that is maintained during the typical school year to assist students and families with consistency and routine. In addition. Students will have online access to course materials and assignments at all times consistent with internet connectivity.
- Regularly scheduled times for peer socialization - including times for less structure, as well as, relationship building activities coordinated by student leaders with faculty advisement.
- Staff Training - Staff will be offered opportunities to receive training in Social and Emotional Learning, student mentoring, and Therapeutic Crisis Intervention.

Tier 2 and 3:

- Social and Emotional health specialists: Students have access to two school social workers, two school counselors, and mental health services through the Family Health network. Students can be referred to the RTI committee for Tier 2 and social emotional learning needs by their teachers. Teachers can also refer a student directly to their building principal, as a member of the student support team. All students have access to a school counselor, with whom they can discuss their needs and resources available to meet them. Families may also contact members of our student support team or classroom teachers with concerns about their child and obtain information about resources that are available. Each specialist in the district is able to provide in school services with varying frequency and direction. They are also a source of information

about referrals to additional professional supports for students in collaboration with families.

- Ally Program - The Ally program is designed to match students with adults in the school community to build positive connections with the school during in person instruction and during remote instruction if circumstances necessitate. Adults in the building will carry out daily check-ins with students with a focus on social and emotional health and ensuring connection with resources available.
- Peer mentoring program - Students in need of additional support, or interested in helping peers may be considered for the peer mentoring program. This layer of support provides students with a trained peer mentor to build positive connections to the Cincinnati school community and facilitate student friendships.
- Referrals to outside agencies - Families, students, and teachers can approach our school social workers or Student Support Team (SST) for assistance with referral to outside agencies who provide the necessary support. Our school social workers will assist families with resources within the district and collaborate with them to ensure access to mental health services for needs that require professional support that is not available or appropriate to be met within the district. The Family Health Network provides professional counseling services to students, upon referral and in collaboration with families, during school hours and meets with them confidentially in the school building.

4. Each school and/or district reopening plan addresses professional development opportunities for faculty and staff on how to talk with and support students during and after the ongoing COVID-19 public health emergency, as well as provide supports for developing coping and resilience skills for students, faculty, and staff.

- Impact of Trauma workshop: The district will provide a workshop on the impact of trauma and trauma informed practices. The impact of trauma workshop discusses how trauma changes the thinking patterns and brain chemistry of those affected by it. The training also provides information about the prevalence of adverse childhood experiences and how their impact can manifest in children and adults throughout their lives.
- Support professionals: School social workers will present information and strategies for facilitating conversations and building capacity for social emotional learning through professional learning communities.
- Employee Assistance Program (EAP): EAP is a service to local school districts through OCM BOCES to provide school employees with support and connections to health and human services when needed. The EAP offers short term counseling through teletherapy to employees and their family members. The EAP also provides a variety of wellness workshops to small groups on topics of interest including: caregiving, time management, healthy eating, and stress management.

- Utilize Professional Learning Communities, Department teams, and grade level teams to build in time for social and emotional support amongst adults. Working with our school social worker and counselors, monthly meetings will establish systems for colleague check-ins and team building.

School Schedules

1. Each school and/or district reopening plan describes the school schedule planned for implementation at the beginning of the 2020-21 school year and to the extent practicable any contingent scheduling models it may consider if the situation warrants.

Due to circumstances outside of our control, we may have to modify how we deliver that instruction at various times throughout the school year. Therefore, we are working on the following 'Conditions' for delivering instruction:

Condition Green - This is the model we are all the most familiar with. This would mean that students and staff operate as our typical school day without social distancing, wearing masks, or have any concerns at all about transmitting a virus among us. Also, we will run our normal bus routes and we will have multiple students in each seat. This may not be practical until there is a vaccine specific to COVID-19.

Condition Yellow - In this model, all students will attend school every day but will honor social distancing guidelines and all staff and students will wear a mask when required. We are limited to 22 students per bus or more if students are from the same household and are able to share seats. Any student that attends BOCES will attend everyday including CTE programs, Alternative Education, or any Special Education Programs.

Condition Orange - In this model, all students in grades UPK through Grade 6 will be attending school each day. Classrooms have been established so that there are less students in these classrooms and we limit their movement throughout the building. In grades 7 - 12, we will follow an A-B Format in which half of each grade level will attend school each day. For students that are in remote learning that day, they will follow their schedule on their chromebook that will be provided. Therefore, they will have access to the teacher in a "live" format, even from home. However, any student that attends BOCES will attend everyday including CTE programs, Alternative Education, or any Special Education Programs.

**For the 2020 - 2021 school year, we have reassigned teachers to grades 1, 2, 3, and 4 to reduce the number of students in each classroom.

Condition Red - In this model, all students will be in remote learning and we will deliver instructional materials through Google Classroom or by hand. We will also deliver food as we were able to do from March to June.

► Attendance & Chronic Absenteeism

Teachers in grades Kindergarten through grade 6 will take attendance in the morning when children arrive. Attendance:

- All students attend school daily while following social distancing guidelines such as; wearing masks, practicing hand hygiene, following specific directionality in hallways, participating in limited transitions, classroom windows and doorways will remain open
 - Teachers and staff will provide ongoing instruction and ample time to practice physical distancing guidelines, handwashing, respiratory etiquette, and mask use
 - Directionality → 1 direction at a time, staggered scheduling
- Daily attendance will be recorded following pre-COVID practice
- Students in UPK and K will attend school in 2 cohorts considering number of total students
 - Cohorts will:
 - remain separate from other cohorts when transitioning due to staggered, scheduled transitions
- Students in grades 1-4 will attend school in small cohorts (3 class groups per grade level)
 - Cohorts will:
 - remain separate from other cohorts when transitioning due to staggered, scheduled transitions

Instructional/Assessment Practices:

- Classroom teachers will use Google Classroom to provide equitable access to content for all students, in school or at home (upload all lessons to Google Classroom, livestream or record lessons as appropriate)
- Classroom teachers will administer SLO assessments
- Classroom teachers establish Essential Learning Standards, create assessments and utilize data from assessments to inform instruction
- Classroom teachers will administer pre/post unit assessments and benchmarks
- Classroom teachers will provide tiered interventions

- TA's and Aides will support teachers to ensure students' learning
- Limited use of shared materials and spaces
 - Keep student personal belongings separate
 - Avoid sharing pencils, scissors, glue, crayons, Chromebook device , etc

 - Avoid centers that include multiple students using it at one time, such as water/sand tables, sensory tables, etc.

Special Education Services

- Students requiring services per their IEP will be given those services as usual.
- Special Education teachers will push into co-taught classrooms as typical practice, and will be utilized in the instruction of all students as appropriate.

Testing accommodations

- Provided for students with IEPs and/or 504 Plans per usual practice and mandates

Students with no or limited internet access at home

- Provided with a thumb drive with materials to use on a computer or other device
- Students will be encouraged to get to a place that has good internet access
 - School parking lot to access public WiFi
 - Presbyterian Church on Deer Path Drive to access public WiFi
 - Via phone.
 - NYS guidelines state that students need “substantive daily interactions” with their teachers.

Social Emotional / Mental Health

- Teachers will provide and integrate explicit instruction to support the SEL Benchmarks & Mental Health wellbeing
 - Will take place through Positivity Project, per normal student-teacher interactions, and our counseling services
 - Counseling services are available through our normal processes with the Middle School Counselor and/or Social Workers as applicable and are

available by scheduled appointment or by “drop in”

Specials/Recess

- Participate in specials in classrooms or outside of the building
- Recess will be held either outside or in their classrooms

2. Each school and/or district reopening plan includes an educational program that is aligned to the New York State Learning Standards (or, for charter schools, the standards set forth in the school's charter) regardless if instruction is delivered in-person, remotely or in a hybrid model.

3. Each school and/or district reopening plan provides for a program that includes regular substantive interaction between teachers and students whether delivered in-person, remotely or through a hybrid model of instruction.

4. Equity must be at the heart of all school instructional decisions. All instruction should be developed so that whether delivered in-person, remotely, or through a hybrid model due to a local or state school closure, there are clear opportunities for instruction that are accessible to all students. Such opportunities must be aligned with State standards (or, for charter schools, the standards set forth in the school's charter) and include routine scheduled times for students to/interact and seek feedback and support/from their teachers.

■ Special Education - Required Notices

1. Each school and/or district reopening plan, whether services are provided in-person, remote, and/or through a hybrid model, addresses the provision of free appropriate public education (FAPE) consistent with the need to protect the health and safety of students with disabilities and those providing special education and services.

Cincinnati Central School District Reopening Plan

Students with disabilities who receive special education services will receive those services in the same format in which instruction is provided to general education students, with appropriate social distancing and protections in place. Classroom capacity plans have taken into account the presence of consultant teachers, teaching assistants, and teacher aides in order to include them in measures to maintain social distancing.

Under a plan to provide general education services to secondary level (grades 7-12) students in a hybrid format, featuring in person instruction every other day, students with disabilities will be prioritized for in person attendance to the extent practicable. Students with disabilities will be prioritized on a case-by-case basis by the type of services required by their individualized education plans, the restrictiveness of the environment in which that service is provided, and individual medical needs of the student. Students with disabilities who need a special class setting that is provided by a collaborating agency (Onondaga-Cortland-Madison BOCES, Broome-Tioga BOCES, George Junior Republic Union Free School District, etc.) will be prioritized for daily in person attendance by our district to the extent that those settings are available to provide services.

Under a plan to provide general education services in a remote learning model, including a hybrid model that reduces capacity to the point that all students with disabilities cannot be prioritized for in person attendance, services will be provided remotely and on the same schedule as they would be provided in person to the extent practicable.

- Students receiving related services will participate in teletherapy sessions with district and contracted providers, over video conferencing or telephonically if video conferencing is not able to be carried out.
- Students receiving direct and indirect consultant teacher services will be provided with modifications and accommodations to learning activities through co-planning with general education teachers, with additional availability to receive support from the direct consultant teacher during video conferencing sessions and extra help periods.
- Students receiving in district special class and resource room services will receive those services through video conferencing to the extent practicable and appropriate for student needs.

2. Each school and/or district reopening plan addresses how it will document the programs and services offered and provided to students with disabilities as well as communications with parents.

To the extent practicable, special education services will be provided in a manner consistent with the services listed on each student's Individualized Education Plan. If services are provided in any manner other than that listed by the student's Individualized Education Plan, due to restrictions on facility and human resource capacity, the change in conditions will be discussed with the student's parent and documented in the communication log of the district's special education software program, Frontline. The completion of an IEP amendment will be considered on a case-by-case basis and dependent upon the nature of the change in condition, anticipated duration of the change, and recommendations of the NYSED.

The case manager will contact each student's parent on their caseload and provide information about the services listed on the Individualized Education Plan and how each of them will be carried out under the reopening guidelines the district is currently adhering to. This communication will take place by phone. If parents are unable to be reached by phone, written communication will be provided to introduce each family to the case manager and review student services. Case managers will ask each parent about their preferred mode of communication, preferred language, and any accommodations needed to access information from the case manager. The case manager will document this information in the communication log on the district special education management software (Frontline).

In the event of a change in general education services, and subsequently special education services, to a plan with reduced facility and human resource capacity, case managers will contact parent(s) of each student on their caseload affected by the change in order to explain the new conditions for providing services. If the parent is unable to be reached by phone, written communication will be provided to outline changes to the conditions of services. If parents have expressed a preference to receive a special mode of communication, communication will be provided in the manner to the extent allowable by NYSED Part 200 Regulations. Related services providers will also contact parents over the phone to explain any change in the conditions or format of services provided.

The CPSE will work with service providers from all counties to provide services consistent with those listed on each student's individualized education plan to the extent practicable. The CSPE will work in accordance with Departments of Health of Cortland, Chenango, and Broome counties to ensure safe practices in accordance with current county guidance. The CPSE will ensure that service providers present families with timely and accessible communication regarding any changes to conditions in which services can take place, based on county guidance.

Students with disabilities who receive services under an Individualized Education Plan will continue to receive the same progress reports, which are provided at the same time as general education progress reports. These reports provided information and data on student progress toward annual goals, as listed on the student's individualized education plan. Special education teachers and service providers are expected to continue to measure progress on annual goals as required and outlined by the IEP to the extent practicable and under the guideline provided by NYSED. Parents will continue to receive these reports whether services are provided in per person, remotely, or via a hybrid model.
